COURSE OBJECTIVES

To allow EMDR therapists to acquire the necessary expertise to adapt The EMDR protocol to the developmental stages of children (toddler, preschool aged children, school aged children, teenagers...) Participants will learn how to adapt the EMDR protocol to their young patients. They will acquire tools to enhance resources, to reprocess early and pre-verbal traumas, and to strengthen the parents' abilities to support the EMDR process.

PUBLIC Anyone who did attend the level I, the basic EMDR accredited course. For the second part of the Masterclass C & A, it is strongly advised to have completed the EMDR Level II training, but it is not mandatory.
