OBJECTIVES

This training is designed in respect of the EMDR Europe criteria's for training EMDR Europe Supervisors and is part of the accreditation curriculum.

This training delivers the theoretical and practical knowledge needed to become an EMDR Europe Supervisor

EMDR FRANCE REQUIREMENTS

1. EMDR Europe accredited practitioner for two years and be member of EMDR France
2. Membership fees payed, national ethics committee agreement (to be asked at EMDR France for French practitioners)
3. At least 16 hours psychotherapy practice per week (sworn statement)
4. EFPE adds here:

Having had a recent supervision showing on video or in vivo your mastery of the 7 phases of the EMDR standard protocol, delivered by an EMDR Europe Consultant accredited since at least 3 years.

This supervision is meant to help you to your own practice from outside. We remind you that the supervisor has to support your integration and help you to update your command of the protocol.

Understanding the AIP model, teaching and supervising will be taught during the training.

The supervisors report has to be sent to the EFPE with your application for the training. Please join a cover letter and the 4 necessary documents to receive the application form.

PROGRAM

18 hours of theoretical teaching about EMDR and psychotraumatology as well as specific protocols.

We should review diagnosis, AIP model and standard protocol, EMDR treatment plan conception.

18 hours of practice centered on individual and group supervision for EMDR students and practitioners depending on their level of knowledge and practice, using role plays and shared thinking.

DURATION 6 days(36 hours) - split into two seminars of 2 and a half days
